### ORDER

WHEREAS a disciplinary proceedings under Rule 14 of CCS (CCA) Rules, 1965 was initiated against Shri A.K. Gour, Technical Assistant Gr.C of Tropical Forest Research Institute, Jabalpur vide Memorandum of charge sheet No.1-4-29/97/Part-2/Estt./TFRI/4171, dt.08-03-2011 with instructions to submit his written statement of defence and also to state whether he desires to be heard in person.

AND WHEREAS in response to the above mentioned charges Shri A.K. Gour, Technical Assistant Gr.C submitted written statement of his defence to the undersigned vide his representation dated 17-03-2011, wherein he denied the charges leveled against him. He also mentioned in his said written statement of defence that he may be heard in person, if required.

AND WHEREAS the undersigned considered that the charges framed against Shri A.K. Gour, Technical Assistant Gr.C should be enquired into and accordingly an Inquiry Authority was appointed vide Order No.1-4-29/97/Estt./TFRI/06, dt.1-4-2011 and subsequently on transfer of Inquiry Officer appointed another Inquiry Officer vide Order No.1-4-29/97/Estt./TFRI/956, dt.30-06-2011.

AND WHEREAS after conducting the enquiry the Inquiring Authority submitted the enquiry report vide his letter dt.13-12-2011.

AND WHEREAS a copy of the enquiry report was forwarded to Shri A.K. Gour, Technical Assistant Gr.C vide letter No.1-4-29/97/Estt./TFRI/3902, dt.29-3-2012 for submitting his representation on the enquiry report and in response of which he submitted his representation dt.24-04-2012 and appeared in person on 27-04-2012 before the undersigned.

AND WHEREAS the undersigned on careful consideration of the enquiry report and other related records etc., in respect of Shri A.K. Gour, Technical Assistant Gr.C, it is proved from the records that he has provided wrong date of birth information to the office and it has been decided that his date of birth was 24-06-1952 and not 24-06-1953. Shri Gour also accepted that his date of birth was 24-06-1952 through his letter dt.13-08-2010 and it is also proved that Shri A.K. Gour suppressed / concealed the factual qualifications acquired during the year 1971 ie., much before his initial appointment as Chowkidar and gained the benefit of promotion from

Chowkidar to Technical Assistant Gr.C in a wrong manner. The undersigned also agreed with the findings of the Inquiry Authority in respect of charges framed against Shri A.K. Gour.

NOW, THEREFORE, the undersigned in exercise of the powers conferred on him by Rule 11 of CCS (CCA) Rules, 1965; FR-29 and ICFRE Rules by taking lenient view in the matter, passed the following orders:

- a. Considering all the aspects of the case and due application of mind, decided that Shri A.K. Gour may be allowed to retire on superannuation on 30-06-2012 on the basis of his date of birth ie., 24-06-1952 mentioned in the Certificate of Board of Secondary Education, Madhya Pradesh, Bhopal.
- b. Shri A.K. Gour is hereby reverted from Technical Assistant Gr.C in the pay scale of PB-1, ₹5200-20200 + ₹2,000/- to Chowkidar now designated as Security Attendant in the pay scale of PB-1, ₹5200-20200 + ₹1,900/- with immediate effect and till he retires from service on superannuation ie., upto 30-06-2012.
