Background Note

Photography Competition by Ministry of Environment, Forest and Climate Change, Government of India during the celebration of Iconic Week 4-10-2021 to 10-10-2021 as a part of AzadiKaAmritMahotsav:

The Ministry of Environment & Forest and Climate Change (MoEF&CC) is the nodal agency in the Central Government for overseeing the implementation of India's environment and forest policies and programmes relating to conservation of the country's natural resources including lakes and rivers, its biodiversity, forests and wildlife, and prevention and abatement of pollution. While implementing these policies and programmes, the Ministry is guided by the principle of sustainable development. The broad objectives of the Ministry are:

- i. Conservation and survey of flora, fauna, forests and wildlife

Terms and Conditions

- 1. All Indian citizens can participate in this competition.
- 2. Image should depict the any of the five topics viz. (i) Tiger (ii) Wildlife(iii) Bird (iv) Flower/Flora (v) Wetlands/Beaches
- 3. Entries violating the technical requirements will not be accepted.
- 4. Copyrighted images will not be accepted for submissions.
- 5. Participants have to ensure that they mention their correct particulars in the Registration Form while submitting their entries. Submitting wrong information may lead to disqualification.
- 6. All Indian citizens are invited to participate in the contest by filling up the enclosed Registration Form.
- 7. The announcement of the winners is the sole discretion of Ministry of Environment, Forest and Climate Change (MoEFCC).
- 8. The prizes will be declared within a month of closure of submission.
- 9. Top entries will be published on the social media handles of MoEFCC.
- 10. The copyright/ ownership of photos submitted shall vest with MoEFCC without any compensation.

Technical Parameters

- i. The maximum size of the image(s) should not exceed 5 MB.
- ii. No watermark or logo or name or imprint should be present on the image.
- iii. Image should be submitted in jpg or jpeg file format.
- iv. Mobile photograph will be accepted provided the quality of the image is not bad.
- v. The entry should not have been previously published in any print and digital media.
- vi. The entry must not contain any provocative, objectionable or inappropriate content.
- vii. Computer-generated or computer-altered/morphed images (other than basic system work) will be disqualified.
- viii. Artwork and illustrations will not be accepted.
- ix. The winner will be declared either through email or by way of announcing.
- x. There will be no notification to participants of rejected entries.
- xi. All entries will be judged based on creativity, originality and composition by MoEFCC.
- xii. Once the winner is declared, they will need to revert by confirmation email within 3 working days or another winner will be chosen.
- xiii. All Expenses incurred for this purpose will be borne by the parties themselves.
- xiv. All disputes/ legal complaints are subject to jurisdiction of Delhi only.
- xv. Payment to the award winner will be made electronically for which necessary bank details will be taken after declaration of winners of the contest.
- xvi. MoEFCC reserves the right to cancel or amend all or any part of the Contest and/ or the Terms & Conditions/ Technical Parameters/ Evaluation Criteria.
